

## Instructions for authors

### How to collaborate?

The "Proyecto Clío" Association publishes the journal CLIO (ISSN 1139-6237), which is recommended to quote, to distinguish it from other homonyms, as "Clio. History and history teaching". This journal is published under Creative Commons Attribution-NonCommercial-NoDerivs 3.0 Spain. You can copy, use, distribute, transmit and publicly display, provided that: i) the authorship and the original source of publication (journal, editorial and URL of the work) is acknowledged; ii) not used for commercial purposes; iii) mentioned the existence and specifications of this license.

Assignment of rights: authors grant exploitation rights to the "Proyecto Clío" Association, editor of the journal, in order to manage its incorporation, if necessary, to different platforms to disseminate scientific content. The assignment of rights document with original signatures must be submitted after knowing the acceptance of the article for publication to the address of the secretary of the Association: Pilar Rivero, Dpto. Didáctica de las Lenguas y de las Ciencias Humanas y Sociales, Facultad de Educación, Universidad de Zaragoza, C/Pedro Cerbuna 12, 50009 Zaragoza (Spain) .

The process for working together is as follows:

#### A) Delivery of manuscripts:

The authors refer to the coordinating team / editor CLIO your text or original material. The materials should be sent to [clio@proyectoclio.com](mailto:clio@proyectoclio.com) (complementary optional address [privero@unizar.es](mailto:privero@unizar.es)). Submissions for publication between January 2 and June 30 of each year are received. It is guaranteed not to evaluate and include the texts received after that date the number of the year. The originality of the submitted material is required; the work must not have been previously published. Contributions should be in .doc or docx with the following template.

#### B) Characteristics of the material submitted for publication

This is an electronic publication and there is no limitation in length. Text or material must be accompanied by abstract in Spanish and English of no more than 10 lines and keywords in both languages (maximum 10). If you include images, these must be free of payment of copyright as well as respect for the right of privacy in the case that images include people. All this, as well as the originality of the text and sent materials is entirely the responsibility of the authors. The appointment system of bibliographic information will be to the APA rules (see [www.apastyle.org](http://www.apastyle.org) or <http://dgb.unam.mx/index.php/submenumain-01/170-como-elaborar-citas-y-referencias-bibliograficas-estilo-apa>). The reviews do not need abstract and keywords and are limited to 4 pages in Times New Roman 12, spacing 1.5.

The text has to include name of the author or authors, institution or workplace and email address authorized to be made public. Sending originals for evaluation and publication constitutes acceptance of these conditions, as well as authorization to "Proyecto Clío"

Association for possible subsequent diffusion in different media, maintaining the evidence of the authorship.

C) Types of materials published.

Authors can send original researches in History Education and in History, articles summarizing the state of affairs of a particular topic of History or analysis of didactic proposals for teaching history, book reviews, websites, blogs, games, learning materials useful for the history classroom. It is also possible to collaborate in specific projects developed by the “Proyecto Clío” Association.

D) Peer review of manuscripts submitted.

Upon receipt of the work, the editorial team checks that all required formal characteristics are met. If not met, it communicates to the authors for them to conduct the review and perform sending a second version. Then articles are evaluated by at least one member of the scientific committee and an outside specialist to it. Upon receipt of both evaluations, the paper is accepted for publication if both are positive and if the reviewers suggest any previous acceptance modification, the authors communicates to proceed to the review of the work and to send a second version. The editorial board and scientific advisory committee publicly listed on the left side of the home page (<http://clio.rediris.es>).

Does it adequately cite the sources of information both textual and graphical?

Is the bibliography is relevant and up to date?

Which of these thematic sections fits better?

Original research (History or history education)

State of the art in History or History education

Analysis of teaching experiences or instructional materials (Subject: History)

Reviews

Any (in this case, what is the relationship with history or History education?)

CONCLUSION: recommendation of the reviewer (mark one)

A. To be published (or with minor formal amendments as are specified in the overall assessment of the article)

B. It can be published after corrections and improvements made background and / or presentation (specified in the overall assessment of the article)

C. It could be published after fixes and improvements made deep background and / or presentation (specified in the overall assessment of the article), given the particular interest of the subject, the relevance of the approach, etc.

D. No publishable in the journal Clío, but in to another journal or publication (to which or what kind ... ..)

E. No publishable

Indicate, if desired, other comments:

Editorial criteria: They will be selected for publication, always mindful of the incorporation of the improvements suggested by the reviewers, those items rated A or B. If maximum discrepancy A / E the manuscript will be sent to a third reviewer. Qualified as "C" items start a new assessment process upon receipt of the second version; the second version of rated B will be reviewed exclusively by members of the editorial or scientific committee to check that they have been made the suggested changes.

E) Data and recognition CLIO

Clío is published continuously since 1998 and annually since 2003. ISSN: 1139-6237; DL: M-9276-1998. It is published by the “Proyecto Clío” Association and is hosted in Rediris by the relevant agreements.

It is recommended that with perseverance published a copy of the article is attached at the time of submission of the merits contests.
